

EMERGENCY OR CRISIS

PERSONAL OR COMMUNITY SAFETY RISK - Always call 9-1-1 in an emergency!
When a person is the victim of an attack OR poses imminent danger to themself or others
Call Great Falls Police immediately by dialing 9-1-1
Or 406.771.1180 (non-emergency) / Campus Security (Securitas) 406.750.8222

PERSONAL OR COMMUNITY SAFETY RISK - Always call 9-1-1 in an emergency!

If a student engages in behaviors that are disruptive or concerning and may include mental health and/ or safety issues (e.g. suicide attempt, suicide ideation, self-harm ideation, self-harm attempt, threats to others, unusual behavior, mental health issues, and/or physical health issues) please report these to the Care and Behavioral Assessment Team (CBAT), to connect students with the relevant resources. Please use the Behavior Referral Form linked on the Faculty and Staff page in the left navigation at **facstaff.gfcmsu.edu** or visit **https://publicdocs.maxient.com/reportingform.php?MSUGreatFalls&layout_id=1**. You may also contact the Chief Student Affairs Officer at 406.771.5123 or 406.771.4304.

Free counseling is available for Great Falls College MSU students through counseling intern students under the supervision of a licensed mental health care professional. Contact Julie Freshly at 406.771.4304; or the Advisors at 406.771.5100 for referral information. Behaviors include severe anxiety, depression, emotional, or mental disturbance, erratic behavior, and/ or suicidal thoughts. See also Behavioral Concern above. If you are aware of a student who has experienced personal tragedy (may impact student's ability to stay in school), or activities or events with negative impact on campus safety, please use the form referrenced above.

DISRUPTIVE BEHAVIOR/ CONDUCT VIOLATIONS

TIPS FOR DEALING WITH A CONCERNING STUDENT

- Always keep safety in mind as you interact. If you feel there is an immediate danger, call 9-1-1.
- Do NOT promise confidentiality.
- Do NOT assume that the person is only trying to get attention or relief from responsibility.
- · Document all interactions.
- Know your limitations and that you should not serve as a counselor.

WHAT INFORMATION IS NEEDED FOR A REFERRAL

- Your name and relationship to the student.
- A phone number at which you can be reached.
- Student's name or GID number.
- A brief, factual explanation of your concern or observation, including dates, times, and location.
- What has been done so far to address the concern.

WHEN TO MAKE A REFERRAL

- Times of emergency or significant distress.
- When your efforts to manage the situation are not effective.
- When/ if past referral efforts have shown little to no improvement.
- If a student asks for help with a personal issue that is outside your role as faculty or staff.
- When you worry that a student might be a danger to themself or others.
- If you are unsure about whether to make a referral or where to make a referral, do not hesitate to contact the office of the Chief Student Affairs Officer at 406.771.5123 or 406.771.4304.

WHAT ABOUT CONFIDENTIALITY

The Family Education Rights and Privacy Act (FERPA) allows the sharing of knowledge about a student among campus officials when there is a legitimate concern related to campus safety.
